# Yolo County Climate Action Commission

---

**Purpose:** The Commission's primary purpose is to make recommendations to the Board on the implementation of the Yolo County Climate Action and Adaptation Plan (CAAP), guided by science, data, best practices, equity, and justice. The Commission will support implementation of the CAAP and associated climate and sustainability programs by reviewing and recommending approval of annual implementation, funding, and engagement plans; advising on new initiatives; and providing early advisory review of high-impact discretionary projects.

**Makeup of membership:** 11 Members

Category A: Five (5) Supervisorial District Representatives – Appointed by Each County Supervisor

Category B: One (1) Environmental Justice Lead – Board Appointed with Staff Recommendation

Category C: One (1) Business Community Lead – Board Appointed with Staff Recommendation

Category D: One (1) Natural and Working Lands Subject Matter Expert – Appointed by Yolo Resource Conservation District (Yolo RCD)

Category E: One (1) Transportation Subject Matter Expert – Appointed by Yolo Transportation District (YoloTD)

The nine-member voting commission will be supported by the Board Subcommittee on Climate, who would serve as non-voting liaisons between the Commission and the remaining County Board of Supervisors. Additionally, one ex-officio non-voting representative from the University of California, Davis and one ex-officio non-voting representative from the Yocha Dehe Wintun Nation will serve on the Commission. The Board may add additional non-voting members at its discretion, including as a result of staff or Commission recommendation.

**Membership terms:** Advisory body members will serve for two years (Category B and C) or three-year (Category A) with opportunities for renewal or replacement. Unless the Board specifically determines otherwise for good cause, in its sole discretion, no member may serve more than two (2) consecutive terms on an advisory committee without at least a one (1) year break in service.
