Makeup of membership: Nine (9) members appointed by the Board of Supervisors:

Three Supervisorial District representatives with two of the District's representatives serving as alternates rotating every two years.

Three to Five Low-income Yolo County residents and/or representatives (as needed)

One to Three Community based organization representatives (as needed)

Membership terms: Board appointees' terms are dependent on the Supervisor's term of office.
4-year terms commencing Jan 1

Frequency and time of meetings: Second Wednesday of every month from 5:30-7:00 p.m., alternating among Woodland, Davis and West Sacramento. For low-income members, travel costs are eligible for reimbursement.
