# Maternal, Child & Adolescent Health Advisory Board

It also reviews and comments on the development and adoption of the required annual County Maternal and Child Health Services Plan. It reports to the Board of Supervisors for Yolo County and local Health Officers. It proposes models, disseminates information, recommends uses of block grant funding, monitors the delivery of acceptable programs, assesses health statistics, and other services that relate to maternal and adolescent health care.
