**Purpose:** Area 4 Agency on Aging is a seven county planning and service area for senior services, funded under the Older Americans Act. They are one of 33 area agencies in California, designated by the State to develop, coordinate, and fund programs designed to help older persons maintain their health and independence Area 4 Agency on Aging (A4AA) is in a Joint Powers Agreement with the counties of Nevada, Placer, Sacramento, Sierra, Sutter, Yolo and Yuba to provide a comprehensive and coordinated system of services for persons 60 years of age and over.
